

SOLICITOR'S DISCLOSURE DOCUMENT

Dear Client:

I am enclosing a copy of the current Form ADV Part 2A (the "Disclosure Brochure") of Integrated Wealth Concepts LLC ("IWC"). This is IWC's Disclosure Brochure under the Investment Advisers Act of 1940 and required by the U.S. Securities and Exchange Commission ("SEC") to be provided to any client or prospective client before establishing a relationship with IWC as your investment advisor.

My services may also include periodic contacts about IWC, or other information as may be requested or required to assist in understanding IWC's services or establishing an advisory relationship or providing/updating information on behalf of IWC. In no event will the services include providing investment advisory services on behalf of IWC in any manner.

The compensation for my services is paid completely by IWC from the investment advisory fees earned, which are not increased or passed along to a client in any way. Therefore, the advisory fees paid to IWC will not be increased as a result of my solicitation services.
